

## Central Lockyer Valley Water Supply Scheme

## Forecast Announced Allocations effective 1 January 2021

A forecast of the announced allocations that you are likely to receive at the start of the new water year on 1 January 2021 has been provided below. These forecasts are based on the current situation and are subject to change if the scheme was to receive significant rainfall events during the upcoming wet season.

The actual announced allocation for the start of the new water year, 1 January 2021 will be posted on Seqwater's website and communicated to you shortly after the start of the new water year.

## Surface water and Morton Vale Pipeline

The forecast AA% for surface water allocations and Morton Vale Pipeline allocations for the new water year, starting 1 January 2020 are set out in the table below. These will be revised should there be significant inflows into Bill Gunn Dam and Clarendon Dam.

Morton Vale Pipeline	Medium priority B - MVP	0%

## Groundwater

If there are no significant changes to the current levels of the monitoring bores used to calculate the groundwater AA% between now and 1 January 2021, the forecast AA% for groundwater will be as per the table below.

Water source	Priority	AA% effective 1 January 2021
Groundwater Water	Low priority A	60%
Groundwater Water	Medium priority A	80%

## Announced Allocation Monitoring Bores

In the table over the page is a list of the monitoring bores that are used for the groundwater AA% assessments as required by the Central Lockyer Valley WSS Operations Manual. The table sets out the depth to the water level in each of the bores for readings taken on 31 March 2020 and 2 November 2020. The last column of the table shows the depth remaining before each bore reaches its historical low level.

The table shows that two bores are already at historical low levels, however it is considered unlikely that the majority of bores will reach historical low levels before 1 January 2021. Because of this unlikelihood, the mandatory 40% AA will not be triggered. However, some bore levels could reach their historical low level within 18 months if there is no recharge.
