

Irrigation pricing (regulated)

For Seqwater customers receiving a regulated irrigation service, the irrigation pricing below applies. An irrigation service is defined in Schedule 4 of the Water Act 2000 as the supply of water for irrigation of crops or pastures for commercial gain.

The Queensland Government sets the regulated irrigation pricing for Seqwater customers, based on recommendations from the Queensland Competition Authority (QCA). In May 2025, the Queensland Government issued a new direction notice setting irrigation prices for two years, from 1 July 2025 until 30 June 2027.

Customers on regulated irrigation pricing maybe eligible for a 15% rebate. More information on the rebate and associated irrigation certification process can be found here: 2025-26 and 2026-27.

Notes

1. Charged annually for zero allocation contracts to cover the administration costs to manage the contract.
2. Usage for Stock & Domestic purposes where the land adjoins a watercourse, lake or spring.
3. Costs associated with undertaking a special read/s generally as part of a sale of property.
4. Costs for design, construction and installation are additional.
5. A transfer adjustment fee is payable where subsidised rural irrigation water is temporarily transferred for non-irrigation usage and is the difference between the subsidised price and the commercial upper bound price.
6. If Seqwater undertakes a Water Allocations Register search, the costs will be passed through to the customer. This charge is set by CITEC and is subject to change.
7. GST inclusive.
8. Applicable to customers receiving irrigation services and invoiced annually in advance.
